1. Eligibility: This Campaign is open only to those who are a residents of the Clinton-Macomb Public Library service area and have a valid library card.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of the Clinton-Macomb Public Library (CMPL) as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting June 16, 2018 on and ending August 18, 2018. All entries must be received by 11:59pm on August 18, 2018.

4. How to Enter: The Campaign must be entered by submitting days of reading and/or activity codes in personal Beanstack accounts at <https://cmpl.beanstack.org/reader365>. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of CMPL. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of CMPL. **Alternate Method of Entry** for individuals with technological issues: You may fill out a paper form at a CMPL reference desk to enter and staff will log Your Beanstack account with days read and activity codes logged.

5. Prizes: Ages 0-18 Winner(s) of the Campaign (the “Winner”) will receive prizes once 15, 30 and 45 days reading are completed. Value of prizes varies. Adults 18+ will receive one entry into a raffle drawing once completing 15, 30 and 45 days of reading.

Four \$25 Target gift cards are raffled for the Activity Code portion of Summer Reading. You may enter this raffle up to 4 times by collecting secret codes. Four badges: Outreach Fanatic, Library Lover, Program Devotee and Digital Downloader are available. Badges are earned when 2 codes are entered into Your Beanstack account. *Target, National Cinemedia and MJR at the Mall at Partridge Creek are not affiliated with this contest.*

Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by CMPL. No cash or other prize substitution shall be permitted except at CMPL discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted.
